### DISCLAIMER (COMPLETE AND FINAL RELEASE FROM ANY AND ALL LIABILITY)

In consideration of acceptance of this application by Indianapolis Motor Speedway, the undersigned does hereby (1) release Indianapolis Motor Speedway Foundation, Inc., Indianapolis Motor Speedway, LLC and their respective staff, volunteers, directors, officers, owners, members, representatives, employees and agents (collectively, "Indianapolis Motor Speedway") from any and all liability arising out of the Historic IndyCar Exhibition ("HIE"), track laps and any other activities related to the HIE including without limitation the commercial exploitation of the event and, liability for personal injury and property damage to the entered car; (2) release all other entrants and officials from any and all liability arising out of the event; (3) warrant that the undersigned has personally read and agrees to comply with the rules and regulations; and (4) give permission to use photographs and information about the entrant's automobile(s) for publication including without limitation inclusion in the program.
